- 1. Call to Order @ 6:43 pm. 10 homeowners were present.
- 2. Financial Report see attached financial reports
 - a. Reviewed 2023 income statement
 - b. Discussed 2024 budget & actual expenses through March
 - i. Annual dues amount was increased to \$300/year to meet the rising costs of maintaining the shared property and in preparation to address the S.B.61 reserve requirements.
- 3. Old Business
 - a. Board Items completed
 - i. Verified homeowner accounts & identified some outstanding balances. Followed collection procedures.
 - ii. Implemented the option to allow email communication which will reduce postage for notices
 - iii. Secured landscaping vendor for 2024

 - ii. Coldharbor monument is not lighting up possible short in the wiring.
 - [*Board response*] Will contact an electrician (preferably the one who did the original installation) as 3 of 4 monuments have issues. Gainer lights remain on and S Old St/Powell may have a short.
 - iii. Neighborhood Garage sale dates scheduled for May 31 Jun 1, 2024
 - iv. Speeding concerns the 25mph sign on Aurora (just off S Old State) doesn't seem to be noticed. Can it be moved down or another added?
 [Board response] This was discussed with the county office and there are specific DOT rules about this; it cannot be moved.
 - v. Interest in opportunities to build community within our neighborhood. Looking forward to spring when residents are outdoors.
 - [Board response] A community mixer was held in October 2023.
 - vi. Fence considering the expense of fence repairs, might we consider removing the fence on E Powell Rd and using a natural boundary line

[*Board response*] Estimates were obtained to present options for a decision. The goal is to have more homeowners included in a decision – repair or remove. It wouldn't have to be "all or nothing."
